### **GENERAL**

The life expectancy of any given product depends on the conditions of use, namely but not limited to, the temperature, the pressure and the contact with chemicals, fuel or oil. It is recommended that product selection be based on laboratory and/or field evaluation, analyzed by a qualified technical resource.

American Biltrite warrants that all first quality goods meet the technical information published in the Product Technical Specification charts and are free from defects in workmanship and material at the time of shipment. This warranty applies to all purchases made after March 19, 2010.

### **PRODUCT WARRANTY**

If a defect covered by this warranty is reported to American Biltrite within one year of purchase, American Biltrite will, at its discretion, make product replacement, repair or refund, after charging for services already rendered.

Without limiting the generality of the foregoing, SUCH WARRANTIES DO NOT COVER: (i) incorrect product selection for the application; (ii) installers' workmanship; (iii) abuse; (iv) length of service on any particular application; (v) "seconds," or "offgoods" which are sold by American Biltrite strictly on an "as is" basis.
