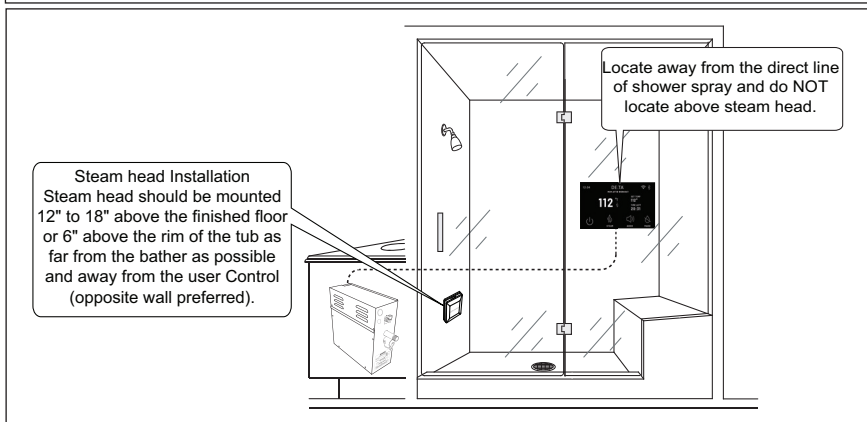
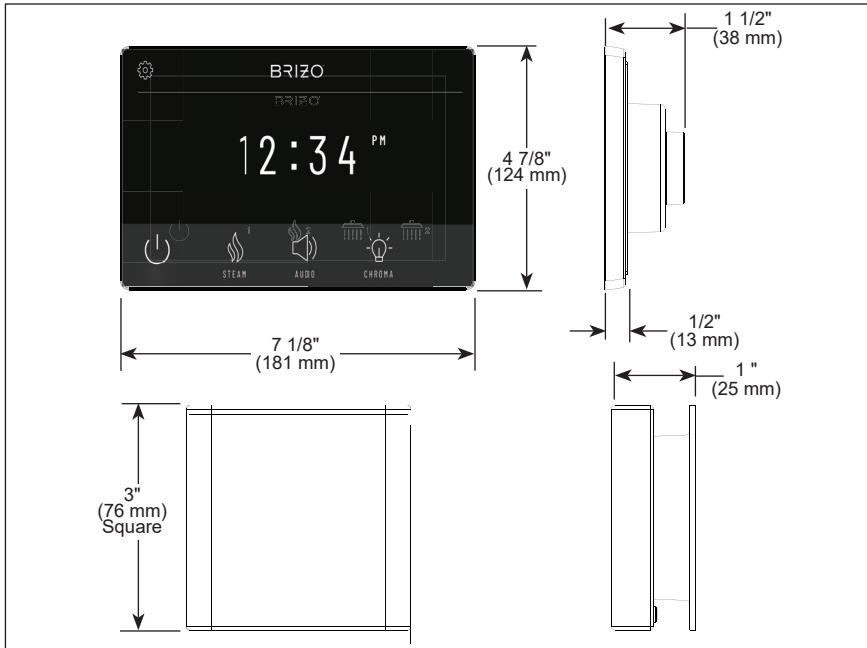

STEAM CONTROL STANDARD SPECIFICATIONS:

- Surface Mount - 2 3/4" hole required
- Must mount inside the steam room
- It is recommended that the multi-conductor cable be run through 3/4" conduit to protect cable from damage and to facilitate easy replacement
- Mount control near seating area and not above steam head
- Control should be mounted 48" above the floor
- If the cable connecting this control to the generator exceeds 35' (to max of 70'), order 8GE-000 power booster
- Required Electrical Service: Low-voltage connection from the 8GE-TSG steam generator via multi-conductor cable (supplied with generator)
- Wi-fi network requirements: Open, WPA, or WPA2
- IMPORTANT: Interface may be installed in a Portrait or Landscape orientation. Please note the "TOP" of control prior to mounting.

STEAM HEAD STANDARD SPECIFICATIONS:

- Includes 3/4" NPT female thread for connection to steam line
- Steam line should protrude 1/4" to 1/2" from finished surface
- Steam head should be mounted 12" - 18" above the finished floor or 6" above the rim of the tub. The mounting location must also not be directly beneath the control and should be as far from the seating area as possible.
- Includes silicone cover
- Essential oil reserve on top of steam head

WARRANTY

- Steam Generators – Lifetime limited warranty; or for commercial purchasers (including for steam bath generators with model numbers beginning with 8GE that are 7.5kW-15kW), one (1) year from the date the product is received by the original purchaser or their authorized representative (installation contractor, etc.).
- Electronic Parts for Steam Bath Generators, Controls, Spa Options and Accessories – two (2) years from the date the product is received by the original consumer purchaser or their authorized representative (installation contractor, etc.); or for commercial purchasers, one (1) year from the date the product is received by the original purchaser or their authorized representative (installation contractor, etc.).
