### LIMITED WARRANTY

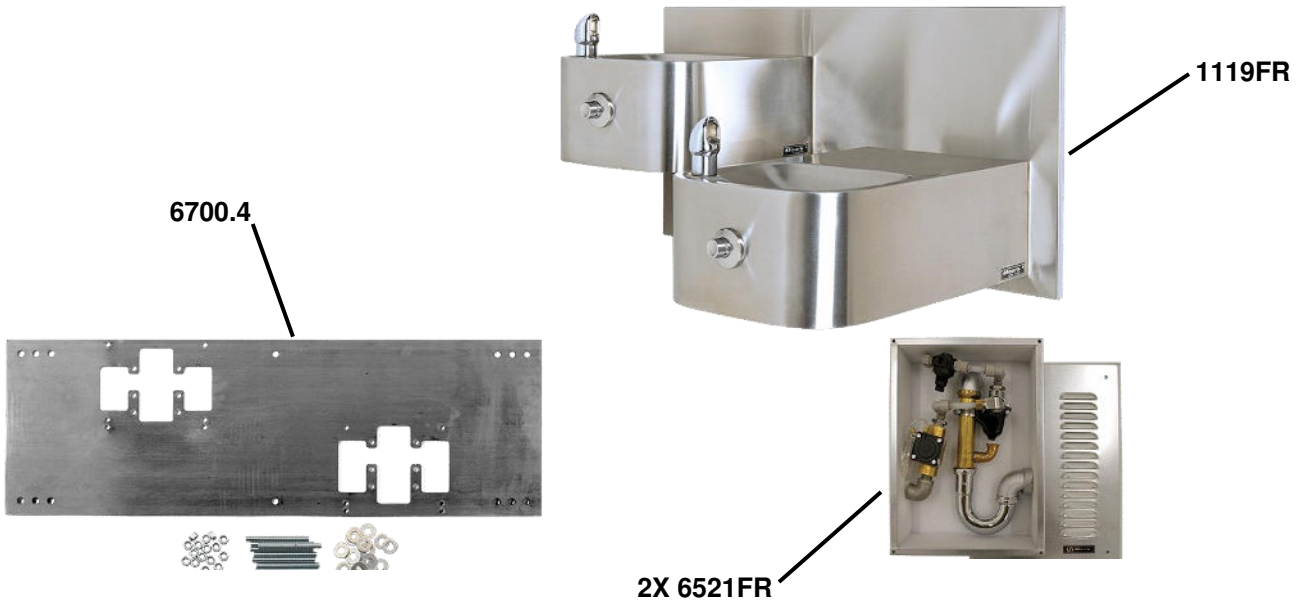

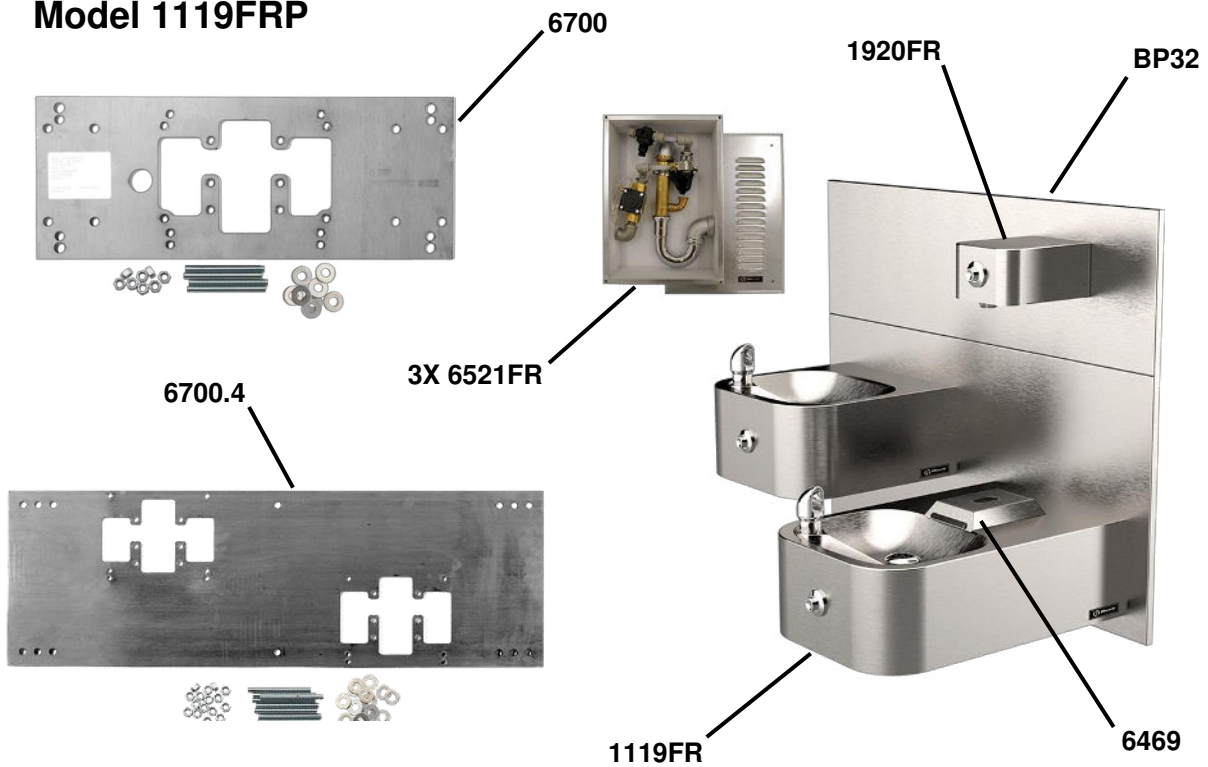

**RECOMMENDED TOOLS:** Hack saw, pipe joint sealant, screwdriver, level, 12" adjustable wrench, 10" pipe wrench, 5/64", 3/32" and 5/32 " hex key wrench, 9/16", 1/2", 7/16" socket wrench or open-end wrench.

**LOCATION OF UNIT:** The Model 1119FR is a wheelchair accessible drinking water facility. The height dimensions shown meet current ADA requirements. When installing this unit, local, state or federal codes should be adhered to. If height other than shown is required, then dimensions must be adjusted accordingly.

**SUPPLY LINE:** The minimum recommended line size is 1/2" IPS with 30-90 psi (2-6 ATM) flowing pressure. Where sediment or mineral content is a problem, an inlet filter is recommended.

**PLUMBING CONNECTIONS:** Inlet valves are 1/2" NPT (F). Waste trap outlets are 1-1/4" NPT (F) (located on 6521FR Valve Boxes).

**MAINTENANCE:** Refer to Operation & Maintenance Manual of each model for information.

## **1119FRB/1119FRP INSTALLATION PROCEDURE**

**NOTE:** The product manuals included in this bundle contain images and directions for various models and configurations. Please note that not all images and configurations are relevant to this bundle.

**NOTE:** This bundle provides all necessary parts for installation, except for mounting hardware for the 6700.4 & 6700 Mounting Plates & 6469 Drip Tray (on 1119FRP model).

Use this manual as a reference for setting up this bundle. Follow the steps below to complete the installation of the 1119FRB or 1119FRP bundle.

### **STEP 1: Install Mounting Plate(s) (6700.4 & 6700)**

Locate and install the 6700.4 and/or 6700 Mounting Plate(s) (both models only include Mounting Hardware for Bowl/Bracket) using the installation instructions located in the 6700 and 6700.4 product boxes. 6700R Mounting Plate (optional) can be used if needed for 1920FR.

### **STEP 2: Install Drinking Fountain (1119FR) & Dual Back Panel (supplied)**

Locate and mount the fountain and dual Back Panel (supplied) on the wall using the installation instructions located in the 1119FR product box.

### **STEP 3: Install Bottle Filler Back Panel (BP32) & Bottle Filler (1920FR)**

*For Model 1119FRB, skip this step.*

Install the BP32 Back Panel and 1920FR bottle filler onto the 6700 (in-wall) Mounting Plate (supplied) or the 6700R (on-wall) Mounting Plate (optional). Use the installation instructions located in the BP32, 1920FR, and 6700 or 6700R product boxes.

### **STEP 4: Install Freeze Resistant In-Wall Valves (6521FR)**

Install the 6521FR Freeze Resistant In-Wall Valve (qty. 2 required on 1119FRB and qty. 3 required on 1119FRP) using the installation instructions located in the 6521FR product boxes.

### **STEP 5: Install Strainer 1920 Drip Tray (6469)**

*For model 1119FRP only.*

Attach the 6469 Strainer 1920 Drip Tray with an appropriate fastening method, using the installation instructions located in the 6469 product box.
