SAFETY CONSIDERATIONS

Installing, starting up, and servicing air- conditioning equipment can be hazardous due to system pressures, electrical components, and equipment location (roofs, elevated structures, etc.).

Only trained, qualified installers and service mechanics should install, start- up, and service this equipment.

Untrained personnel can perform basic maintenance functions such as coil cleaning. All other operations should be performed by trained service personnel only. When working on the equipment, observe the precautions in the literature and on tags, stickers, and labels attached to the equipment.

Follow all safety codes. Wear safety glasses and work gloves. Keep a quenching cloth and a fire extinguisher nearby when brazing. Use care in handling, rigging, and setting bulky equipment. Read these instructions thoroughly and follow all warnings or cautions included in the literature and attached to the unit. Consult local building codes and National Electrical Code (NEC) for special requirements. Recognize safety information.

Do not bury more than 36 in. (914 mm) of refrigerant pipe in the ground. If any section of pipe is buried, there must be a 6 in. (152 mm) vertical rise to the valve connections on the outdoor units. If more than the recommended length is buried, refrigerant may migrate to the cooler buried section during extended periods of system shutdown. This causes refrigerant slugging and could possibly damage the compressor at start-up.

A WARNING

ELECTRICAL WARNINGS

Only use the specified wire. If the wire is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.

The product must be properly grounded at the time of installation, or electric shock may occur.

For all electrical work, follow all local and national wiring standards, regulations, and the Installation Manual. Connect cables tightly, and clamp them securely to prevent external forces from damaging the terminal. Improper electrical connections can overheat and cause fire, and may also cause shock. All electrical connections must be made according to the Electrical Connection Diagram located on the panels of the indoor and outdoor units.

All wiring must be properly arranged to ensure that the control board cover can close properly. If the control board cover is not closed properly, it can lead to corrosion and cause the connection points on the terminal to heat up, catch fire, or cause electrical shock.

Disconnection must be incorporated in the fixed wiring in accordance with the wiring rules.

Do not share the electrical outlet with other appliances. Improper or insufficient power supply can cause fire or electric shock.

If connecting power to fixed wiring, an all-pole disconnection device which has at least 3mm clearances in all poles, and have a leakage current that may exceed 10mA, the residual current device (RCD) having a rated residual operating current not exceeding 30mA, and disconnection must be incorporated in the fixed wiring in accordance with the wiring rules.

Turn o? the air conditioner and disconnect the power before performing any installation or repairing. Failure to do so can cause electric shock. Installation must be performed by an authorized dealer or specialist. Defective installation can cause water leakage, electrical shock, or fire. Contact an authorized service technician for repair or maintenance of this unit.

This appliance shall be installed in accordance with national wiring regulations.

When moving or relocating the air conditioner, consult experienced service technicians for disconnection and re-installation of the unit.

How to install the appliance to its support, please read the information for details in "indoor unit installation" and "outdoor unit installation" sections.

FOR FLAMMABLE REFRIGERANTS

Do not use means to accelerate the defrosting process or to clean, other than those recommended by the manufacturer.

The appliance shall be stores in a room without continually operating ignition sources (for example: open flames, an operating gas appliance or an operating electric heater).

Do not burn or pierce.

Be aware that refrigerants may not contain an odor.

NOTE: The air conditioner's circuit board (PCB) is designed with a fuse to provide overcurrent protection. The specifications of the fuse are printed on the circuit board, for example: T3.15AL/250VAC, T5AL/250VAC, T3.15A/250VAC, T5A/250VAC, T20A/250VAC, T30A/250VAC, etc.

NOTE: Only the blast-proof ceramic fuse can be used.

1. Installation (where refrigerant pipes are allowed)

Any person who is involved with working on or breaking into a refrigerant circuit should hold a current valid certificate from an industry-accredited assessment authority, which authorizes their competence to handle refrigerants safely in accordance with an industry recognized assessment specification.

Maintenance and repair requiring the assistance of other skilled personnel shall be carried out under the supervision of the person competent in the use of flammable refrigerants.

The installation of pipe-work shall be kept to a minimum.

Pipe-work shall be protected from physical damage.

Where refrigerant pipes shall be compliance with national gas regulations.

That mechanical connections shall be accessible for maintenance purposes.

Be more careful that foreign matter (oil, water, etc.) does not enter the piping. When storing the piping, securely seal the opening by pinching, taping, etc.

All working procedure that affects safety means shall only be carried by competent persons.

Appliance shall be stored in a well ventilated area where the room size corresponds to the room area as specific for operation. Joints shall be tested with detection equipment with a capability of 1/8 oz (5g)/year of refrigerant or better, with the equipment in standstill and under operation or under a pressure of at least these standstill or operation conditions after installation.

In cases that require mechanical ventilation, ventilation openings shall be kept clear of obstruction.

- Because a FLAMMABLE REFRIGERANT is used, the requirements for installation space of appliance and/or ventilation requirements are determined according to:
 - the refrigerant charge used in the appliance,
 - the installation location,
 - the type of ventilation of the location or of the appliance.
 - piping material, pipe routing, and installation shall include protection from physical damage in operation and service, and be in compliance with national and local codes and standards, such as ASHRAE 15, IAPMO Uniform Mechanical Code, ICC International Mechanical Code, or CSA B52. All field joints shall be accessible for inspection prior to being covered or enclosed.
 - that protection devices, piping, and fittings shall be protected as far as possible against adverse environmental effects, for example, the danger of water collecting and freezing in relief pipes or the accumulation of dirt and debris;
 - that piping in refrigeration systems is designed and installed to minimize the likelihood of hydraulic shock damaging the system;
 - that steel pipes and components shall be protected against corrosion with a rustproof coating before applying any insulation;
 - that precautions shall be taken to avoid excessive vibration or pulsation;

- the minimum floor area of the room shall be mentioned in the form of a table or a single figure without reference to a formula;
- after completion of field piping for split systems, the field pipework shall be pressure tested with an inert gas and then vacuum tested prior to refrigerant charging, according to the following requirements:
 - a. The required nitrogen test pressure is 500 PSI.
- b. The test pressure after removal of pressure source shall be maintained for at least 1 hour with no decrease of pressure indicated by the test gauge, with test gauge resolution not exceeding 5% of the test pressure.
- c. During the evacuation test, after achieving a vacuum level specified in the manual or less, the refrigeration system shall be isolated from the vacuum pump and the pressure shall not rise above 1500 microns within 10 min. The vacuum pressure level shall be specified in the manual, and shall be the lessor of 500 microns or the value required for compliance with national and local codes and standards, which may vary between residential, commercial, and industrial buildings.
- Field-made refrigerant joints indoors shall be tightness tested according to the following requirements: The test method shall have a sensitivity of 1/8 oz (5 g) per year of refrigerant or better under a pressure of at least 125% of the maximum allowable pressure. No leak shall be detected.

3. Qualification of Workers

Any maintenance, service and repair operations must be performed by skilled and authorized personnel. Every working procedure that affects safety means shall only be carried out by competent persons that joined the training and achieved competence should be documented by a certificate. The training of these procedures is carried out by national training organizations or manufacturers that are accredited to teach the relevant national competency standards that may be set in legislation. Examples for such working procedures are:

- breaking into the refrigerating circuit;
- opening of sealed components;
- opening of ventilated enclosures.

Information Servicing

1. Checks to the Area

Prior to beginning work on systems containing flammable refrigerants, safety checks are necessary to ensure that the risk of ignition is minimized. For repair to the refrigerating system, the following precautions shall be complied with prior to conducting work on the system.

2. Work Procedure

Check that cabling is not subjected to wear, corrosion, excessive pressure, vibration, sharp edges or any other adverse environmental effects. The check shall also take into account the effects of aging or continual vibration from sources such as compressors or fans.

3. General work area

All maintenance staff and others working in the local area shall be instructed on the nature of work being carried out. work in confined spaces shall be avoided.

4. Checking for presence of refrigerant

The area shall be checked with an appropriate refrigerant detector prior to and during work, to ensure the technician is aware of potentially flammable atmospheres. Ensure that the leak detection equipment being used is suitable for use with flammable refrigerants, i.e. no sparking, adequately sealed or intrinsically safe.

5. Presence of fire extinguisher

If any hot work is to be conducted on the refrigeration equipment or any associated parts, appropriate fire extinguishing equipment shall be available to hand. Have a dry power or CO2 fire extinguisher adjacent to the charging area.

6. No ignition sources

No person carrying out work in relation to a REFRIGERATING SYSTEM which involves exposing any pipe work shall use any sources of ignition in such a manner that it may lead to the risk of fire or explosion. All possible ignition sources, including cigarette smoking, should be kept sufficiently far away from the site of installation, repairing, removing and disposal, during which refrigerant can possibly be released to the surrounding space. Prior to work taking place, the area around the equipment is to be surveyed to make sure that there are no flammable hazards or ignition risks. "No Smoking" signs shall be displayed.

7. Ventilated area

Ensure that the area is in the open or that it it adequately ventilated before breaking into the system or conducting any hot work. A degree of ventilation shall continue during the period that the work is carried out. The ventilation should safely disperse any released refrigerant and preferably expel it externally into the atmosphere.

8. Checks to the refrigeration equipment

Where electrical components are being changed, they shall be fit for the purpose and to the correct specification. At all times the manufacturer's maintenance and service guidelines shall be followed. If in doubt consult the manufacturer's technical department for assistance. The following checks shall be applied to installations using FLAMMABLE REFRIGERANTS:

- the actual refrigerant charge is in accordance with the room size within which the refrigerant containing parts are installed;
- the ventilation machinery and outlets are operating adequately and are not obstructed;
- if an indirect refrigerating circuit is being used, the secondary circuits shall be checked for the presence of refrigerant;
- marking to the equipment continues to be visible and legible, marking and signs that are illegible shall be corrected;
- refrigeration pipe or components are installed in a position where they
 are unlikely to be exposed to any substance which may corrode
 refrigerant containing components, unless the components are
 constructed of materials which are inherently resistant to being
 corroded or are suitably protected against being so corroded.

9. Checks to electrical devices

Repair and maintenance to electrical components shall include initial safety checks and component inspection procedures. If a fault exists that could compromise safety, then no electrical supply shall be connected to the circuit until it is satisfactorily dealt with. If the fault cannot be corrected immediately but it is necessary to continue operation, and adequate temporary solution shall be used. This shall be reported to the owner of the equipment so all parties are advised.

Initial safety checks shall include:

- that capacitors are discharged: this shall be done in a safe manner to avoid possibility of sparking
- that there no live electrical components and wiring are exposed while charging, recovering or purging the system;
- that there is continuity of earth bonding

10. Sealed electrical components shall be replaced.

11. Intrinsically safe components must be replaced.

12. Cabling

Check that cabling will not be subject to wear, corrosion, excessive pressure, vibration, sharp edges or any other adverse environmental effects. The check shall also take into account the effects of aging or continual vibration from sources such as compressors or fans.

13. Detection of Flammable Refrigerants

Under no circumstances shall potential sources of ignition be used in the searching for or detection of refrigerant leaks. A halide torch (or any other detector using a naked flame) shall not be used. The following leak detection methods are deemed acceptable for refrigerant systems. Electronic leak detectors may be used to detect refrigerant leaks but, in the case of FLAMMABLE REFRIGERANTS, the sensitivity may not be adequate, or may need re-calibration. (Detection equipment shall be calibrated in a refrigerant-free area.) Ensure that the detector is not a potential source of ignition and is suitable for the refrigerant used. Leak detection equipment shall be set at a percentage of the LFL of the refrigerant and shall be calibrated to the refrigerant employed, and the appropriate percentage of gas (25% maximum) is confirmed. Leak detection fluids are also suitable for use with most refrigerants but the use of detergents containing chlorine shall be avoided as the chlorine may react with the refrigerant and corrode the copper pipework.

NOTE Examples of leak detection fluids are

- · bubble method,
- fluorescent method agents.

If a leak is suspected, all naked flames shall be removed/extinguished.

If a refrigerant leak is found which requires brazing, all of the refrigerant shall be recovered from the system, or isolated (by means of shut off valves) in a part of the system remote from the leak. See the following instructions for removal of refrigerant.

14. Removal and evacuation

When breaking into the refrigerant circuit to make repairs - or for any other purpose conventional procedures shall be used. However, for flammable refrigerants it is important that best practice be followed, since flammability is a consideration.

The following procedure shall be adhered to:

- safely remove refrigerant following local and national regulations;
- · evacuate;
- purge the circuit with inert gas (optional for A2L);
- evacuate (optional for A2L);
- continuously flush or purge with inert gas when using flame to open circuit; and
- · open the circuit

The refrigerant charge shall be recovered into the correct recovery cylinders if venting is not allowed by local and national codes. For appliances containing flammable refrigerants, the system shall be purged with oxygen-free nitrogen to render the appliance safe for flammable refrigerants. This process might need to be repeated several times. Compressed air or oxygen shall not be used for purging refrigerant systems.

For appliances containing flammable refrigerants, refrigerants purging shall be achieved by breaking the vacuum in the system with oxygen-free nitrogen and continuing to fill until the working pressure is achieved, then venting to atmosphere, and finally pulling down to a vacuum (optional for A2L). This process shall be repeated until no refrigerant is within the system (optional for A2L). When the final oxygen-free nitrogen charge is used, the system shall be vented down to atmospheric pressure to enable work to take place. The outlet for the vacuum pump shall not be close to any potential ignition sources, and ventilation shall be available.

15. Charging procedures

In addition to conventional charging procedures, the following requirements shall be followed:

- Works shall be undertaken with appropriate tools only (in case of uncertainty, consult the manufacturer of the tools for use with flammable refrigerants)
- Ensure that contamination of different refrigerants does not occur when using charging equipment. Hoses or lines shall be as short as possible to minimize the amount of refrigerant contained in them.
- Cylinders shall be kept upright.
- Ensure that the refrigeration system is earthed prior to charging the system with refrigerant.
- Label the system when charging is complete (if not already).
- Extreme care shall be taken not to overfill the refrigeration system.
- Prior to recharging the system it shall be pressure tested with oxygen free nitrogen (OFN). The system shall be leak tested on completion of charging but prior to commissioning. A follow up leak test shall be carried out prior to leaving the site.

16. Decommissioning

Before carrying out this procedure, it is essential that the technician is completely familiar with the equipment and all its detail. It is recommended good practice that all refrigerants are recovered safely. Prior to the task being carried out, an oil and refrigerant sample shall be taken in case analysis is required prior to re-use of recovered refrigerant. It is essential that electrical power is available before the task is commenced.

- a. Become familiar with the equipment and its operation.
- b. Isolate system electrically
- Before attempting the procedure ensure that:

 mechanical handling equipment is available, if required, for handling refrigerant cylinders;
 - •all personal protective equipment is available and being used correctly;
 - •the recovery process is supervised at all times by a competent person;
 - •recovery equipment and cylinders conform to the appropriate standards.
- d. Pump down refrigerant system, if possible.
- e. If a vacuum is not possible, make a manifold so that refrigerant can be removed from various parts of the system.
- f. Make sure that cylinder is situated on the scales before recovery takes place.
- g. Start the recovery machine and operate in accordance with instructions.
- Do not overfill cylinders (no more than 80% volume liquid charge)
- Do not exceed the maximum working pressure of the cylinder, even temporarily.
- j. When the cylinders have been filled correctly and the process completed, make sure that the cylinders and the equipment are removed from site promptly and all isolation valves on the equipment are closed off.
- Recovered refrigerant shall not be charged into another refrigeration system unless it has been cleaned and checked.

17. Labeling

Equipment shall be labeled stating that it has been de-commissioned and emptied of refrigerant. The label shall be dated and signed. For appliances containing FLAMMABLE REFRIGERANTS, ensure that there are labels on the equipment stating the equipment contains FLAMMABLE REFRIGERANT.

18. Recovery

When removing refrigerant from a system, either for servicing or decommissioning, it is recommended good practice that all refrigerants are removed safely.

When transferring refrigerant into cylinders, ensure that only appropriate refrigerant recovery cylinders are employed. Ensure that the correct number of cylinders for holding the total system charge is available. All cylinders to be used are designated for the recovered refrigerant and labeled for that refrigerant (i. e. special cylinders for the recovery of refrigerant). Cylinders shall be complete with pressure-relief valve and associated shut-o valves in good working order. Empty recovery cylinders are evacuated and, if possible, cooled before recovery occurs.

The recovery equipment shall be in good working order with a set of instructions concerning the equipment that is at hand and shall be suitable for the recovery of the flammable refrigerant. If in doubt, the manufacturer should be consulted. In addition, a set of calibrated weighing scales shall be available and in good working order. Hoses shall be complete with leak-free disconnect couplings and in good condition.

The recovered refrigerant shall be processed according to local legislation in the correct recovery cylinder, and the relevant waste transfer note arranged. Do not mix refrigerants in recovery units and especially not in cylinders. If compressors or compressor oils are to be removed, ensure that they have been evacuated to an acceptable level to make certain that flammable refrigerant does not remain within the lubricant. The compressor body shall not be heated by an open flame or other ignition sources to accelerate this process. When oil is drained from a system, it shall be carried out safely.

19. Transportation, marking and storage for units

- a. Transport of equipment containing flammable refrigerants Compliance with the transport regulations
- Marking of equipment using signs/Compliance with local regulations
- c. Disposal of equipment using flammable refrigerants/ Compliance with national regulations
- d. Storage of equipment/appliances/The storage of equipment should be in accordance with the manufacturer's instructions.
- e. Storage of packed (unsold) equipment/Storage package protection should be constructed such that mechanical damage to the equipment inside the package will not cause a leak of the refrigerant charge. The maximum number of pieces of equipment permitted to be stored together will be determined by local regulations.




Fig. 2 — Outdoor Unit





This ensures that rain drips from the connection pipe before it enters the wall.




Fig. 3 — Sizes 09K/12K




Fig. 4 — Size 18K






Fig. 5 — Size 24K








Fig. 6 — Sizes 30K and 36K




Fig. 7 — Clearances




Fig. 8 — Clearances for Multiple Units

INSTALLATION

A WARNING

Prior to Installation

Before installing the indoor unit, ensure the compatibility with the outdoor unit using the product data as a reference. It is also necessary to confirm the proper application of the equipment and to perform a heat load calculation for proper sizing.

- A location which is convenient to installation and not exposed to strong winds.
- A location which can bear the weight of the outdoor unit and where the outdoor unit can be mounted in a level position.
- A location which provides appropriate clearances (see Fig. 8).
- Allow sufficient space for airflow and service of the unit. See Fig. 8 for the required minimum distances between the unit or walls.

NOTE: DO NOT install the indoor or outdoor units in a location with special environmental conditions. For those applications, contact your Ductless representative.

A WARNING

PRODUCT INSTALLATION

Installation must be performed by an authorized dealer or specialist. A defective installation can cause water leakage, electrical shock, or fire.

The installation must be performed according to the installation instructions. Improper installation can cause water leakage, electrical shock, or fire. (In North America, installation must be performed in accordance with the requirements of NEC or CEC by authorized personnel only.)

Contact an authorized service technician for repair or maintenance of this unit. This appliance must be installed in accordance with local codes.

Only use the included accessories, parts, and specified parts for installation. Using non-standard parts can cause water leakage, electrical shock, fire, or unit failure.

To prevent exposure to wind, install the outdoor unit with its air inlet side facing the wall

IMPORTANT: Both refrigerant lines must be insulated separately. Use refrigeration grade tubing ONLY. No other type of tubing may be used. Use of other types of tubing will void the manufacturer's warranty.

- The minimum refrigerant line length between the indoor and outdoor unit is 10 ft. (3m).
- When paired with Ductless indoor units, size the line sets based on the connection size of the indoor unit unless specified.
- When paired with conventional or multi-family fan coils, size the line sets based on the liquid and gas connection size of the outdoor unit; a field supplied reducer may be required.
- All outdoor units have an electronic expansion valve to manage the refrigerant flow of the fan coil connected.
- Do not open the service valves or remove the protective caps from the tubing ends until all connections are made.
- Bend the tubing with bending tools to avoid kinks and flat spots.
- Keep the tubing free of dirt, sand, moisture, and other contaminants to avoid damaging the refrigerant system.
- Avoid sags in the suction line to prevent the formation of oil traps.
- Insulate each tube with a minimum 3/8-in. (10 mm) wall thermal pipe insulation. Inserting the tubing into the insulation before making the connections saves time and improves installation quality.

A WARNING

All field piping must be completed by a licensed technician and must comply with the local and national regulations.

When the system is installed in a small room, measures must be taken to prevent the refrigerant concentration in the room from exceeding the safety limit in the event of refrigerant leakage. If the refrigerant leaks and its concentration exceeds its proper limit, hazards due to lack of oxygen may result.

When installing the refrigeration system, ensure that air, dust, moisture or foreign substances do not enter the refrigerant circuit. Contamination in the system may cause poor operating capacity, high pressure in the refrigeration cycle, explosion or injury. Ventilate the area immediately if there is refrigerant leakage during the installation.

Leaked refrigerant gas is hazardous. Ensure there is no refrigerant leakage after completing the installation work.

A CAUTION

DO NOT install the connecting pipe until both the indoor and outdoor units have been installed.

Insulate both the gas and liquid piping to prevent condensation.






NOTE: PRIOR TO INSTALLATION

Before installing the outdoor unit, you must choose an appropriate location. The following are standards that will help you choose an appropriate location for the unit.

Proper installation locations meet the following standards:







Good air circulation and ventilation.



Firm and solid—the location can support the unit and will not vibrate.



Noise from the unit will not disturb other people.



Protected from prolonged periods of direct sunlight or rain.



Where snowfall is anticipated, take appropriate measures to prevent ice buildup and coil damage.



Install the unit by following local codes and regulations , there may be differ slightly between different regions.


DO NOT install unit in the following locations:

- Near an obstacle that will block air inlets and outlets
- Near a public street, crowded areas, or where noise from the unit will disturb others.
- Near animals or plants that will be harmed by hot air discharge.
- Near any source of combustible gas.
- In a location that is exposed to large amounts of dust
- In a location exposed to a excessive amounts of salty air.


Step 2 - Install Drain Joint

NOTE: PRIOR TO INSTALLATION

Before bolting the outdoor unit in place, you must install the drain joint at the bottom of the unit. For the units with base pan built-in with multiple holes for proper draining during defrost, the drain joint is no need to be installed.



Step 1: Find out the base pan hole of outdoor unit.



Step 2:

- Fit the rubber seal on the end of the drain joint that will connect to the outdoor unit.
- Insert the drain joint into the hole in the base pan of the unit. The drain joint will click in place.
- Connect a drain hose extension (not included) to the drain joint to redirect water from the unit during heating mode.



NOTE: IN COLD CLIMATES


In cold climates, make sure that the drain hose is as vertical as possible to ensure swift water drainage. If water drains too slowly, it can freeze in the hose and flood the unit.



- The outdoor unit can be anchored to the ground or to a wall-mounted bracket with bolt(M10). Prepare the installation base of the unit according to the dimensions below.

If you install the unit on the ground or on a concrete mounting platform, do the following:

- Mark the positions for four expansion bolts based on dimensions chart.
- Pre-drill holes for expansion bolts.
- Place a nut on the end of each expansion bolt.
- Hammer expansion bolts into the pre-drilled
- Remove the nuts from expansion bolts, and place outdoor unit on bolts.
- Put washer on each expansion bolt, the replace the nuts.
- Using a wrench, tighten each nut until snug.

If you install the unit on a wall-mounted bracket, do the following:


- Mark the position of bracket holes based on dimensions
- Pre-drill the holes for the expansion bolts.
- Place a washer and nut on the end of each expansion bolt.
- Thread expansion bolts through holes in mounting brackets, put mounting brackets in position, and hammer expansion bolts into the wall.
- Check that the mounting brackets are level.
- Carefully lift unit and place its mounting feet on brackets.
- Bolt the unit firmly to the brackets.
- If allowed, install the unit with rubber gaskets to reduce vibrations and noise.


Ensure the wall is made of solid brick, concrete, or of similarly strong material. The wall must be able to support at least four times the weight of the unit.

Step 4 - Connect Signal and Power Cables


- All wiring work must be performed strictly in accordance with the wiring diagram located inside of wire cover of the outdoor unit.
- Before performing any electrical or wiring work, turn off the main power to the system.







The outside unit's terminal block is protected by an electrical wiring cover on the side of the unit. A comprehensive wiring diagram is printed on the inside of the wiring cover.

- Remove the wire cover from the unit by loosening the 3 screws.
- Dismount caps on the conduit panel.
- Temperarily mount the conduit tubes(not included) on the conduit panel.
- Properly connect both the power supply and low voltage lines to the corresponding terminals on the terminal block.
- Ground the unit in accordance with local codes.
- Be sure to size each wire allowing several inches longer than the required length for wiring.
- Use lock nuts to secure the conduit tubes.

Step 5 - Refrigerant Connection

- 1. Run the interconnecting piping from the outdoor unit to the indoor unit.
- Connect the refrigerant piping and drain line outside the indoor unit. Complete the pipe insulation at the flare connection then fasten the piping and wiring to the wall as required. Completely seal the hole in the wall.
- 3. Cut tubing to the correct length.

When preparing refrigerant pipes, take extra care to cut and flare them properly. This ensures efficient operation and minimizes the need for future maintenance.

- a. Measure the distance between the indoor and outdoor units.
- Using a pipe cutter, cut the pipe a little longer than the measured distance.
- c. Make sure the pipe is cut at a perfect 90° angle.




Fig. 9 —Pipe Cutting

A CAUTION

DO NOT DEFORM PIPE WHILE CUTTING

Be extra careful not to damage, dent, or deform the pipe while cutting. This will drastically reduce the heating efficiency of the unit.

4. Remove Burrs

Burrs can affect the air-tight seal of the refrigerant piping connection. Therefore, they must be completely removed.

To remove:

- a. Hold the pipe at a downward angle to prevent burrs from falling into the pipe.
- b. Using a reamer or deburring tool, remove all burrs from the cut section of the pipe.




Fig. 10 — Deburring Tool

5. Flare Pipe Ends

Proper flaring is essential to achieving an airtight seal.

- After removing the burrs from the cut pipe, seal the ends with PVC tape to prevent foreign materials from entering the pipe.
- b. Sheath the pipe with insulating material.
- c. Place factory flare nut on pipe facing the proper direction. Make sure they are facing the right direction. Once the ends are flared, it is impossible to put them on or change their direction.




Fig. 11 — Copper pipe and flare nut

- d. Remove the PVC tape from ends of pipe when ready to perform the flaring work.
- e. Clamp the flare block on the end of the pipe. The end of the pipe must extend beyond the flare form.




Fig. 12 — Flare Block

- f. Place the flaring tool onto the form.
- g. Turn the handle of the flaring tool clockwise until the pipe is fully flared. Flare the pipe in accordance with the dimensions in Table 10.




Fig. 13 — Flare Nut Spacing

 Remove the flaring tool and flare block, then inspect the end of the pipe for cracks and even flaring.

6. Connect the Pipes

Connect the copper pipes to the indoor unit first, then connect the pipes to the outdoor unit. Connect the low-pressure pipe first, then connect the high pressure pipe. When connecting the flare nuts, apply a thin coat of refrigeration oil to the flared ends of the pipes.

a. Align the center of the two pipes that you will connect.




Fig. 14 — Align the center of the two pipes

- b. Tighten the flare nut as much as possible by hand.
- c. Using a wrench, grip the nut on the unit tubing.
- d. While firmly gripping the nut, use a torque wrench to tighten the flare nut according to the torque values listed in Table 11.




Fig. 15 — Flare Shape




Fig. 16 — Torque wrench with backup wrench

A CAUTION

Wrap insulation around the piping. Direct contact with the bare piping may result in burns or frostbite. Ensure the pipe is properly connected. Over tightening may damage the bell mouth and under tightening may lead to leakage.

All tubing bends should be performed with a properly sized tubing bender to prevent kinking or damaging the tubing.

e. After connecting the copper pipes to the indoor unit, wrap the power cable, signal cable and the piping together with binding tape.

NOTE: While bundling these items together, DO NOT intertwine or cross the signal cable with any other wiring.

- Thread this lineset through the wall and connect it to the outdoor unit.
- g. Insulate all piping, including the outdoor unit valves.

NOTE: DO NOT open the service valves until pressure test is complete.

7. Pressure Test Piping

A CAUTION

Only use Dry Nitrogen to pressure test refrigerant systems. Use of other gases can result in injury, property damage or death.

NOTE: Use refrigeration gauges that are pressure rated for R454b refrigerant.

- Attach low side gauge hose to the 5/16" Schrader valve on the outdoor unit service valve.
- Attach the charging hose to the regulator on the dry nitrogen tank.
- c. Preset the nitrogen regulator to 550 psi.
- d. Slowly pressurize the line set until the low side gauge reads 500 psi. Do not exceed 550 psi.
- e. Close all the valves on the nitrogen tank and gauges.
- f. Allow the pressure test to stand for a minimum of 30 minutes.
- g. If the pressure holds, release the nitrogen and proceed. Review "TEST RUN" on page 32.
- h. If the pressure goes down in the 30 minute delay, leak check the tubing and flare fittings to identify the source of the leak.

 Return to Step C, above.

NOTE: Carefully bend the tubing in the middle. DO NOT bend the tubing more than 90° or more than 3 times'

WIRING INSTRUCTION

Wiring Precautions

WARNING - BEFORE PERFORMING ANY ELECTRICAL WORK, READ THESE WARNINGS.

All wiring must comply with local and national electrical codes, regulations and must be installed by a licensed electrician.

All electrical connections must be made according to the Electrical Connection Diagram located on the panels of the indoor and outdoor units.

If there is a serious safety issue with the power supply, stop work immediately. Explain your reasoning to the client, and refuse to install the unit until the safety issue is properly resolved.

Power voltage should be within 90-110% of rated voltage. (Insufficient power supply can cause malfunction, electrical shock, or fire.

Installation of an external surge suppressor at the outdoor disconnect is recommended.

If connecting power to fixed wiring, a switch or circuit breaker that disconnects all poles and has a contact separation of at least 1/8in (3mm) must be incorporated in the fixed wiring. The qualified technician must use an approved circuit breaker or switch.

Only connect the unit to an individual branch circuit. Do not connect another appliance to that outlet.

Make sure to properly ground the air conditioner.

Every wire must be firmly connected. Loose wiring can cause the terminal to overheat, resulting in product malfunction and possible fire.

Do not let wires touch or rest against refrigerant tubing, the compressor, or any moving parts within the unit.

If the unit has an auxiliary electric heater, it must be installed at least 40in (1 m) away from any combustible materials.

To avoid getting an electric shock, never touch the electrical components soon after the power supply has been turned off. After turning o the power, always wait 10 minutes or more before you touch the electrical components.

Ensure you do not cross your electrical wiring with your signal wiring. This may cause distortion, interference or possibly damage to circuit boards

No other equipment should be connected to the same power circuit. Connect the outdoor wires before connecting the indoor wires.

WARNING

Before performing any electrical or wiring work, turn off the main power to the system.

Connect Signal and Power Cables

A WARNING

All wiring work must be performed strictly in accordance with the wiring diagram located in the wire cover of the outdoor unit. Before performing any electrical or wiring work, turn off the main power to the system.




Fig. 17 — Sizes 09K, 12K, 115V




Fig. 18 —Sizes 09K, 12K, 18K 208-230




Fig. 19 —Size 24K 208-230




Fig. 20 - Size 30K 208-230




Fig. 21 — Size 36K 208-230




Fig. 22 — Sizes 09K-12K (115V)




Fig. 23 — Sizes 09K, 12K, 18K, 24K (208/230V)




Fig. 24 — Sizes 30K and 36K

NOTES:

- Do not use the thermostat wire for any connection between indoor and outdoor units.
- All connections between the indoor and outdoor units must be made as shown in Figure 23. The connections are sensitive to polarity and will result in a fault code.

The outside unit's terminal block is protected by an electrical wiring cover on the side of the unit. A comprehensive wiring diagram is printed on the inside of the wiring cover.

- 1. Remove the wire cover from the unit by loosening the 3 screws.
- 2. Dismount the caps on the conduit panel.
- Temporarily mount the conduit tubes (not included) on the conduit panel.
- Properly connect both the power supply and low voltage lines to the corresponding terminals on the terminal block.
- 5. Ground the unit in accordance with local codes.
- Be sure to size each wire allowing several inches longer than the required length for wiring.
- 7. Use lock nuts to secure the conduit tubes.

WIRING

All wires must be sized per NEC (National Electrical Code) or CEC (Canadian Electrical Code) and local codes. Use Electrical Data table MCA (minimum circuit amps) and MOCP (maximum over current protection) to correctly size the wires and the disconnect fuse or breakers respectively.

Power and Communication Wiring: The main power is supplied to the outdoor unit. The field supplied 14/3 power/communication wiring, from the outdoor unit to the indoor unit, consists of four (4) wires and provides the power for the indoor unit. Two wires are high voltage AC power, one is communication wiring and the other is a ground wire.

To minimize communication interference: If installed in a high Electromagnetic field (EMF) area and communication issues arise, a 14/2 stranded shielded wire can be used to replace 2 (L2/N) and 3 (S) between the outdoor and indoor units - landing the shield onto the ground in the outdoor unit only.

No wire should touch the refrigerant tubing, compressor or any moving parts. Disconnecting means must be provided and shall be located within sight and readily accessible from the air conditioner. Connecting cable with conduit shall be routed through the hole in the conduit panel.

EVACUATION COIL AND TUBING SYSTEM

A CAUTION

UNIT DAMAGE HAZARD

Failure to follow this caution may result in equipment damage or improper operation. Never use the system compressor as a vacuum pump.

Refrigerant tubes and the indoor coil should be evacuated using the recommended 500 microns deep vacuum method. The alternate triple evacuation method may be used if the procedure outlined below is followed.

NOTE: Always break a vacuum with dry nitrogen.

NOTE: The service port (Schrader Fitting) for R454b refrigerant is a special fitting that requires a new type adapter. The Service Port Adapter used for R410A refrigerant units will not work with the new equipment. This new adapter uses Reverse threads (Left-Hand Thread) and must be obtained from distributor or supply house.




Fig. 25 — Service Valve




Fig. 26 — Manifold

Evacuation

Evacuation of the system removes air or nitrogen (non-condensables) as well as moisture. A proper vacuum assures a tight, dry system before charging with refrigerant. The two methods used to evacuate a system are the Deep Vacuum Method and the Triple Evacuation Method.

Deep Vacuum Method




Fig. 27 — Deep Vacuum Graph

The deep vacuum method requires a vacuum pump capable of pulling a vacuum of 500 microns and a vacuum gauge capable of accurately measuring this vacuum depth. The deep vacuum method is the most positive way of assuring a system is free of air and moisture (see Figure 27).

Triple Evacuation Method




Fig. 28 — Triple Evacuation Method

The triple evacuation method should be used when the vacuum pump is not capable of pumping down to 500 microns and system does not contain any liquid water. Refer to Fig. 28 and proceed as follows:

- Attach refrigeration gauges and evacuate system down to 28 in. of mercury and allow pump to continue operating for an additional 15 minutes.
- 2. Close service valves and shut off vacuum pump.
- Connect a nitrogen cylinder and regulator to system and flow nitrogen until system pressure is 2 psig.
- Close service valve and allow system to stand for 1 hour. During this
 time, dry nitrogen will be able to diffuse throughout the system
 absorbing moisture.
- Repeat this procedure as indicated in Fig. 28. System will then be free of any contaminants and water vapor.

Final Tubing Check

IMPORTANT: Check to be certain factory tubing on both the indoor and outdoor unit has not shifted during shipment. Ensure tubes are not rubbing against each other or any sheet metal. Pay close attention to the feeder tubes, making sure wire ties on feeder tubes are secure and tight.

A CAUTION

Refrigerant charging must be performed after wiring, vacuuming, and the leak testing.

DO NOT exceed the maximum allowable quantity of refrigerant or overcharge the system. Doing so can damage the unit or impact it's functioning. Charging with unsuitable substances may cause explosions or accidents. Ensure that the appropriate refrigerant is used.

Refrigerant containers must be opened slowly. Always use protective gear when charging the system.

DO NOT mix refrigerants types.

TEST RUN

A CAUTION

Failure to perform the test run may result in unit damage, property damage, or personal injury.

Before Test Run

A test run must be performed after the entire system has been completely installed. Confirm the following points before performing the test:

- 1. Indoor and outdoor units are properly installed.
- 2. Piping and wiring are properly connected.
- 3. No obstacles near the inlet and outlet of the unit that might cause poor performance or product malfunction.
- 4. Refrigeration system does not leak.
- 5. Drainage system is unimpeded and draining to a safe location.
- 6. Heating insulation is properly installed.
- 7. Grounding wires are properly connected.
- Length of the piping and additional refrigerant capacity have been recorded.
- 9. Power voltage is the correct voltage for the air conditioner

Run Test Instructions

- 1. Open both the liquid and gas stop valves.
- 2. Turn on the main power switch and allow the unit to warm up.
- 3. Set the air conditioner to **COOL** mode.
- 4. For the Indoor Unit
 - a. Ensure the remote control and its buttons work properly.
 - Ensure the louvers move properly and can be changed using the remote control.
 - Double check to see if the room temperature is being registered correctly.
 - d. Ensure the indicators on the remote control and the display panel on the indoor unit work properly.
 - e. Ensure the manual buttons on the indoor unit works properly.
 - Check to see that the drainage system is unimpeded and draining smoothly.
 - g. Ensure there is no vibration or abnormal noise during operation.

5. For the Outdoor Unit

- a. Check to see if the refrigeration system is leaking.
- Ensure there is no vibration or abnormal noise during operation.
- b. Ensure the wind, noise, and water generated by the unit do not disturb your neighbors or pose a safety hazard.

Drainage Test

- Ensure the drainpipe flows smoothly. New buildings should perform this test before finishing the ceiling.
- Remove the test cover. Add 1/2 gallon of water to the tank through the attached tube.
- Turn on the main power switch and run the air conditioner in COOL mode.
- d. Listen to the sound of the drain pump to see if it makes any unusual noises.
- e. Check to see that the water is discharged. It may take up to one minute before the unit begins to drain depending on the drainpipe.
- f. Make sure that there are no leaks in any of the piping.
- g. Stop the air conditioner. Turn off the main power switch and reinstall the test cover.

NOTE: If the unit malfunctions or does not operate according to your expectations, please refer to the Troubleshooting section of the Owner's Manual before calling customer service.

CARE AND MAINTENANCE

To help ensure high performance and minimize possible equipment failure, periodic maintenance must be performed on this equipment. Maintenance frequency may vary depending upon geographic areas.

TROUBLESHOOTING

For ease of service, the systems are equipped with diagnostic code display LEDs on both the indoor and outdoor units. The outdoor diagnostic display has one red LED on the outdoor unit board and is limited to very few errors. The indoor diagnostic display is a combination of flashing LEDs on the display panel or the front of the unit. There may be a few error codes displayed in the indoor unit that might relate to the outdoor unit's problems. If possible, always check the diagnostic codes displayed on the indoor unit first.
