GENERAL

Two-level wall mounted drinking fountain constructed of #14 gauge, type 304, stainless steel polished to a lustrous satin finish.

Contoured basin minimizes splashing and has vandal-resistant bubbler. Keyed in location to prevent rotation. Easy to operate, fully functional push-buttons are vandal-resistant. Vandal-resistant bottom cover plates included. Flow regulator provides constant stream from 20 to 105 psi water pressure.






CONSTRUCTION

EHWM17C furnished complete with vandal-resistant bubbler, fully assembled front push-buttons, flow regulator (20 to 105 psi), and drain, vandal-resistant 14 gauge bottom cover plates and surface mounting plate. Trap furnished by others.





INSTALLER NOTE

THIS DRINKING FOUNTAIN IS FURNISHED WITH A BUBBLER AND WATERWAY WITH ALL CONNECTING FITTINGS WHICH ARE MANUFACTURED OF COMPLETELY LEAD FREE MATERIAL. SHUT OFF VALVE (NOT FURNISHED) TO ACCEPT 3/8" O.D. UNPLATED COPPER TUBE.
