


Aktiva Showerhead with Arm 27470 Aktiva Showerhead 28490

Installer Notes:


This is a specialty showerhead. For best results, Hansgrohe recommends that this be used only with a 3/4" thermostatic mixer and a 3/4" volume control valve. Do not use this showerhead with a pressure balancing mixer.

Due to the weight of this showerhead, Hansgrohe recommends that it be used only with the shower arm included with the 27470, or with the 27431 Large Cast Shower Arm, available separately.


The 28490 can be used in a ceiling installation provided that the supply pipe is properly secured.

Installation Instructions-27470

- 1. Install 1/2" male supply pipe, extending 3/8" from the surface of the finished wall.
- Seal the wall around the pipe using a good quality bathroom sealer.
- 3. Install the mounting bracket to the supply pipe.
- Secure the mounting bracket to the wall using the screws provided.
- 5. Slide shower arm through the trim plate and over the mounting bracket. Secure the arm to the mounting bracket with the set screw.
- 6. Mount the showerhead on the shower arm.

User Instructions

The selector knob on the side allows the user to select regular spray, pulsating massage spray, and soft aerated spray.

When the modes are changed, green Quick-Clean pins automatically clear the spray channels of any mineral deposits.

Care Instructions

All finishes: Clean with a mild soap and water solution. Rinse thoroughly with clear water and polish dry with a soft cloth.

Do not use cleaners containing acids, solvents, or abraisives.

Damage caused by improper care is not covered under the Hansgrohe USA warranty.

Polished Brass: after each use, wipe gently with a damp cloth and blot dry with a soft cloth.
