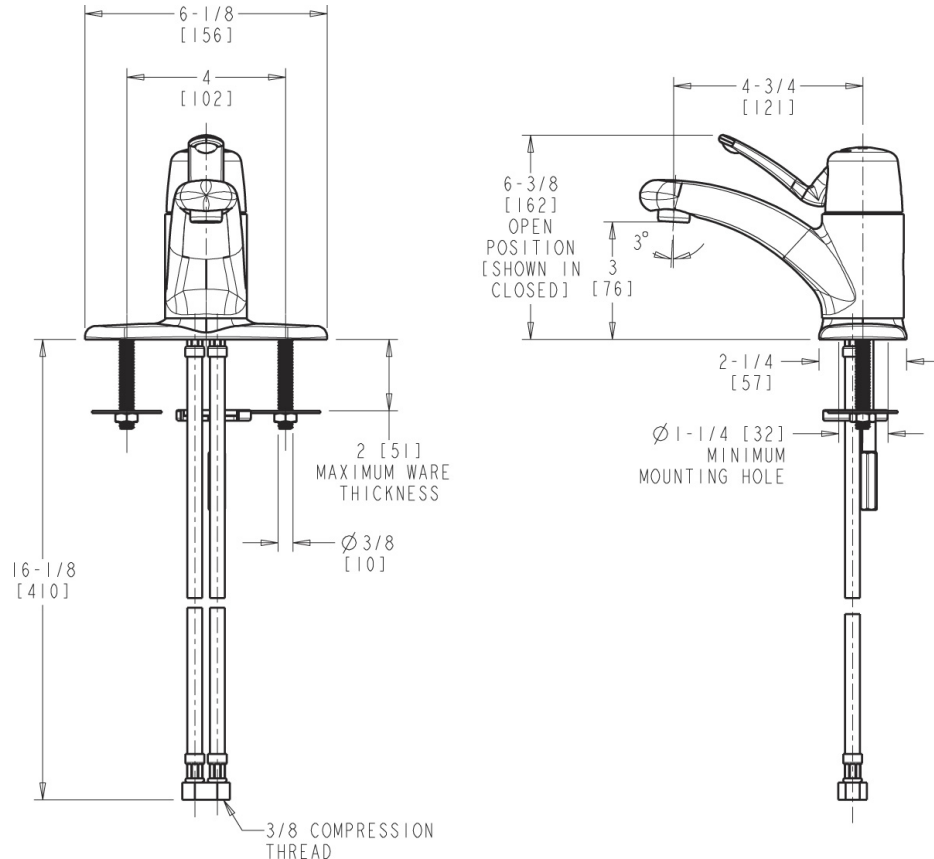

Chicago Faucets No. 2200-4E2805ABCP, Sink Faucet for hot and cold water, single lever, deck-mounted with 4" fixed centers, chrome plated. Integral cast brass spout, 4-3/4" center-to-center. 0.5 GPM (1.9 L/min) vandal-proof, pressure compensating, Econo-Flo, non-aerating spray. 2-3/4" metal lever handle. Ceramic quarter-turn cartridge, features square, tapered stem. Flexible stainless steel supply hoses with 3/8" compression fitting. ECAST® construction with less than 0.25% lead content by weighted average. CALGreen compliant. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9 by CSA, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, NSF/ANSI 372 Low Lead Content, and California Green Building Standards Code (CALGreen).



## Operation and Maintenance
