## Uponor ProPEX® Lead-free Brass Fire Sprinkler Adapter

### Why Lead-free\* Brass?

Recent lead-reduction legislation from states such as California (AB1953) and Vermont (S152) now require any plumbing product intended to convey or dispense potable tap (drinking) water must not contain more than 0.25% weighted average lead on wetted surfaces. With states such as Washington and Maryland proposing their own lead-reduction legislation, more and more states are predicted to follow suit.

Because Uponor's AquaSAFE™ is a multipurpose system (meaning it combines the cold potable plumbing and the fire sprinkler system), it is important to provide products that will meet this new legislation.

\*Per NSF Annex G, lead-free products contain not more than 0.25% weighted average lead content on wetted surfaces.

### Why Fire Sprinklers?

On Jan. 1, 2011, the 2009 International Residential Code will require fire sprinklers in every new one- and two-family home built in the United States. Why are sprinklers being mandated in every new home? Quite simply, they help save lives and property.

**Note:** Installation requires one Fire Sprinkler Adapter Mounting Bracket (A7750700) and one Push-on Nut (F7000005) for each Lead-free Brass Fire Sprinkler Adapter Tee (LF7707575 or LF7701010). Mount the bracket using #10 x  $1\frac{1}{2}$ " screws (F7001500) or equivalent.

## Fire Sprinkler Adapter Installation

- Attach the mounting bracket to the structure with two screws (F7001500). If using the lower mounting holes, install a third screw in the center hole.
- 2. Snap the fire sprinkler adapter into the mounting bracket.
- Install the Push-on Nut (F7000005) over the threaded portion of the fire sprinkler adapter.

**Note:** When using the upper mounting holes, the installer can also preassemble the sprinkler adapter and mounting bracket (with or without the sprinkler head).

**Note:** Dimensions shown are for typical ceiling or wall construction and may not apply in all applications. Always verify the sprinkler is properly positioned after finishing ceilings and walls.

### Why is Uponor offering a lead-free brass fire sprinkler adapter?

### When is the current legislation set to take effect?

California and Vermont have already approved their proposed lead-free legislation, which takes effect Jan. 1, 2010. Once a state's legislation is approved and takes effect, all suppliers of metallic, potable-water components must prove their products meet the lead-level criteria by complying with the minimum requirement from the National Sanitation Foundation (NSF).

### Do the sprinkler heads also need to be lead free?

Not necessarily. Depending on local regulations, if the plumbing connections are limited to nonpotable fixtures, the system may not have to be lead free. However, to increase design and installation options, Uponor is actively pursuing sources for lead-free sprinkler heads.

### Does this lead-free requirement affect Uponor's PEX tubing?

No, Uponor's PEX tubing contains no lead-level concerns.

### Is there a warranty?

Yes, Uponor offers a 25-year warranty on AquaPEX tubing and ProPEX fittings when installed by an Uponor-trained professional.

### How does AquaSAFE work?

AquaSAFE is a multipurpose system, which means the potable cold-water plumbing and fire sprinklers are combined. This type of system provides added peace of mind because it confirms fresh water is available to the sprinklers each time a cold-water plumbing fixture is used. Also, because it is a non-stagnant system, AquaSAFE does not require the use of expensive check valves or backflow preventers.
