INSTRUCTIONS:

- Store and apply between 40 degree F and 120 degree F. Use below 40 degree F only with proper solvent cement and with extreme care.
 Wear non-permeable gloves during application to avoid skin contact.

- Cut pipe end square and remove ragged edges and burrs. Clean fitting socket and pipe, and check for proper fit.
 Using supplied dauber applicator, apply CLEANER evenly and freely to socket and then to pipe end for length of socket depth. Then apply again to socket. Avoid puddling. For pipe greater than 2" diameter use natural-bristle sized to 1/2 of the pipe diameter.
- 5. Temperature and humidity conditions may require repeated applications to one or both surfaces to avoid drying. While still wet, quickly apply proper solvent cement and make up pipe joint in accordance with cement's instructions.
