The 3M™ Aqua-Pure™ Whole House Water Filtration System, AP900 Series offering the industry's first Sanitary Quick Change (SQC) whole house system. The innovative Sanitary Quick Change (SQC) design allows for fast and easy cartridge change-outs without having to contact the filter media or the need for a filter wrench. These systems are referred to as point-of-entry (POE) systems and are installed downstream from the water meter or well pump. Stainless steel inlet and outlet connections provide easy installation for a plumbing professional and peak flow rates up to 20 gpm to meet the needs of residential applications. The 304 stainless steel head can be installed on existing copper pipes in the home. It consists of a corrosion resistant material that provides long service life.

Product Benefits:

- Helps to provide consistent high quality water for whole house filtration
- 100,000 gallon capacity (approximately one year cartridge life under most water quality conditions)
- Ideal for drinking water filtration at point of entry in small to large homes and light commercial buildings.
- Three systems:
 - AP902: Particulate¹; Filter incorporates a non-woven pleat media that reduces sediment down to 5 micron nominal.
 - -AP903: Particulate and Chlorine Taste & Odor¹; Incorporates carbon block filtration with a non-woven pleat media for reduction of chlorine, taste and odor and for reduction of sediment down to 5 micron.
 - -AP904: Particulate and Chlorine Taste & Odor'; Incorporates carbon block filtration with a non-woven pleat media and scale inhibition media for reduction of chlorine, taste and odor and sediment down to 5 micron and to help reduce potential build-up of hardness scale in water using applications like hot water heaters.
- Sanitary Quick Change (SQC) design, an industry first for this application, allows for fast and easy cartridge change-outs without the need of a filter wrench
- 304 stainless steel head allows for sweat in place installation and is a corrosion resistant material
- 1" inlet and outlet connections for easy installation and peak flow rates up to 20 gpm (75.7 lpm)
- Capacity tested at high flow rates of 10 gpm and even at intermittent peak flow rates of 20 gpm to help meet most residential and light commercial applications


