



Vertical inlet extension	1"	Add "Z" to Cat. No.

Place catalog inlet tube code to the left of any other extension option from the top option table. Example: VBHC94-21W-41-44SK-NL


### Service Line Size

- ASSE 1024 approved cartridge dual check valve
