Slight citrus aroma produced by citrus based ingredient, no added fragrance or dye. Cartridges contain 3250 milliliters and are ultrasonically sealed, non-vented, and fully recyclable (HDPE Type 2). EcoLogo™ certified, USDA BioPreferred accreditation, and VOC compliant. Formulated for one dose application. Dispensed from proprietary, Biocote® protected dispenser at the rate of 3 milliliters per push.

Usage: For use in restrooms and hand washing areas to remove all types of dirt and grime at break times, before meals, end of shift or other times as needed. Not for use in food contact areas.

Method of Use: Apply 1 dose to dry hands and work in to loosen all soilings. Rinse well with clean, running water and dry hands thoroughly.
