

B-1097 Diverter Valve Installation Instructions





TOOLS NEEDED

#2 Phillips screwdriver 5/64" Hex key wrench

INSTALLATION

- 1. With the valve in an upright "T" position, make sure the internal ball flow holes are at the bottom (Inlet) and right (Handheld Shower) threaded ports. The left (Shower Head) port will show the polished ball.
- 2. Remove the handle screw and handle.
- 3. Remove escutcheon and sleeve.
- 4. Rough-in the valve in an upright "T" position.
- 5. After wall is finished, slide the sleeve onto the valve spindle until bottomed. The sleeve slot should nest over the valve hex and not rotate.
- 6. Loosen but do not remove the set screw to push the escutcheon against the finished wall. The "HAND SPRAY" marking on the escutcheon should be at the 12 o'clock position. Tighten set screw.
- 7. Reinstall the handle in the down position.

Note: Although normal operation only requires 90 degrees of handle rotation, the handle can turn a full 360 degrees.

8. Test for proper flow to the handheld shower spray then to the shower head. If the flow does not match the handle positions, turn the handle until flow is to the handheld shower only then reposition the escutcheon and handle as described above in steps 6 and 7.
