# Use Overview



Pro Strip™ SC High Efficiency Floor Stripper is a powerful stripper that quickly bites through layers of floor finish, decreasing downtime and labor costs, while reducing the odors associated with floor stripping. This highly concentrated low odor floor stripper is not formulated with ammonia or butyl.

- Dilute or dispense using cold water.
- Apply liberal amounts of stripping solution uniformly to floor with mop. Start at edges to provide more soak time.
- Let stripper solution soak for 10–15 minutes.
- Use mop to agitate and re-wet as necessary.
- Hand or machine scrub thoroughly using black pads or stripping brush.
- Pick up solution with a mop, wet-vac or autoscrubber.
- Thoroughly rinse floor with clean water.
- Let floor dry completely before applying a Diversey Green Seal™-certified finish or other recommended Diversey brand floor finish or sealer.
