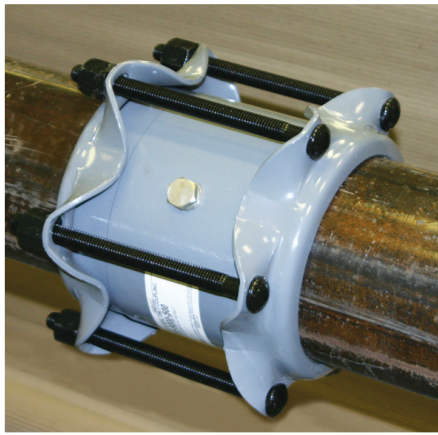

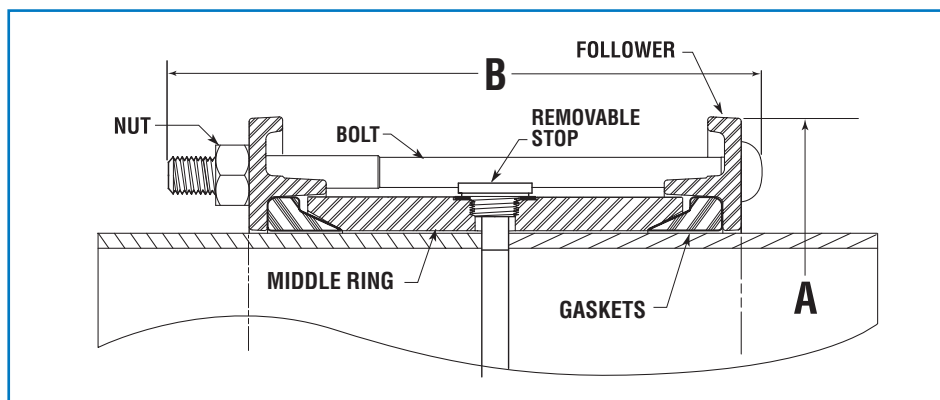

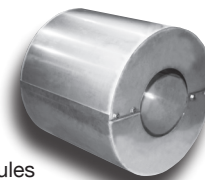

 Gaskets: Grade 42 Buna N (Others available upon request)
 Coating: Fusion-Bonded Epoxy as Standard
