You will be required to show written documentation supporting (a) or (b). If you are unable to provide written documentation supporting either (a) or (b), the Warrant Period commencement date will be determined by WESTCRAFT<sup>™</sup> based on the WESTCRAFT<sup>™</sup> product serial number.

# WESTCRAFT'S™OBLIGATIONS

WESTCRAFT'S<sup>™</sup> obligations under the warranty set forth in paragraph 1 above shall be to replace free of charge any WESTCRAFT<sup>™</sup> disposal or component which is defective as stated above or at WESTCRAFT'S<sup>™</sup> option, to either refund the purchase price or repair the disposal.
